Invitation to an international academic conference

Inspiring social and economic leaders are able to transform a conflictual human settlement into a collaborative and caring human community. Can we induce from their 'way of doing things' a model of civic entrepreneurship and leadership that can inspire people in profit, non-profit and public organizations? To what extent is the will to serve compatible with the will to maximize profit or the will to gain economic, political or religious power? Do different spiritual traditions create different models and examples of servant leadership? This conference is part of the *Damien project* of the European SPES Institute, a research project that focuses on Spirituality in Action through servant leadership and social entrepreneurship. It also connects to the research into leadership at the Institute of Leadership and Social Ethics.
